As acting President, hello to all FMPV members. It's been a very challenging year and hopefully we are moving to a more 'normal ' lifestyle with lifting of restrictions in the near future. Many functions had been organised for 2020 but unfortunately only 3 have been enjoyed before Covid rules intervened.

The committee has been meeting regularly with the assistance of Zoom, and future issues and proposed functions, that would conform with current regulations, were discussed.

Unfortunately, the decision was made to cancel the Comparative Tasting Dinner because of the uncertainties of restrictions, and the November AGM and Christmas BBQ has been rescheduled to February 2021. Please be aware the new date will not change if restrictions apply but will be held electronically. More information at a later date.

Another agenda item creating a great deal of discussion was the clubs finances and options for 2021 Membership fees. As you would realise there are many ongoing costs to enable an organisation to operate. In the past FMPV wine cellar was being privately cellared free of charge, but it is now necessary for part of the collection to use professional storage space. Extra wine was purchased for 2020 planned functions which as we know unfortunately didn't eventuate. Another major cost this year has been the setting up of our website

(morningtonwinefriends) with the associated annual fees and ongoing costs.

Members will be advised when the launch happens. Sue Sewell has taken on the final stages of this project and the goal is to launch online asap.

During our lengthy discussions about what to do for 2021 membership fees, we were very conscious there had been an increase in fees for this year.

A great program for the year was planned, BUT, as we know, Covid 19 happened. which put an end to this.

Membership fees are usually due on the 1st November, the end of our financial year being 31st October. with the AGM following very soon after. As the AGM is now deferred until February 2021, payment of the 2021 fees is also deferred until 1st March 2021. This gives 3 months free membership to members renewing their membership for 2021. The fee for existing membership for 2021 will be determined at the committee meeting held before the AGM.

Looking forward to the resumption of our functions in 2021 and everyone stay safe and well.
